



Fee structure

The fee structures for The Tanto International School, TASC - Tanto After School Club and The English Nursery are completely separate. This document will give you an overview of the fee terms in these three departments. Please note that all fees include costs for materials, meals and obligatory trips.

The Tanto International School Fees for 2020-2021

A yearly fee apply for Years 1-7.

The fee can be paid in one instalment, or two instalments at an additional cost. The two instalments are invoiced with 60% due before the term start in August and 40 % due in February.

The general fee structure below is based on the child having a “personnummer” (Swedish Social Security number) which ensure government subsidies.

If your child does not have a “personnummer” the fee level is higher to compensate the loss of government subsidies.

The current school fees are:

Yearly Fees for Year 1 to 7

44 600 SEK* / **46 600 SEK***

Option 1: Single instalment of the yearly fee.

**Option 2: The yearly fee is split into two instalments per year.
60% paid by 1st August and 40% paid by 1st February.**

** If the subsidy from a student's home council (kommun) is significantly lower than the average councils', we reserve the right to charge a higher fee in order to compensate.*

An initial, one off, waiting list fee of 200 SEK is required to place your child on our waiting list. Once you have submitted the online application form the administration will confirm receipt of the application and issue an invoice for the school's waiting list.

A 5000 SEK non-refundable deposit is due at the time of enrolment (for new students -payment date stipulated on the offer sent out individually) or no later than February 1st (for current students) to secure a place for August. The deposit is part of the fee once the child is enrolled in School.

An initial, one off, registration fee of 1500 SEK is required to enrol all new students.

Payment of the school fee is always required in advance. Your child may not start a term until the fee has been paid in full.

Students are enrolled for the complete term and it is not possible to reduce or refund fees for delayed entry or absence.

If you are planning to withdraw your child, the school requests that you give a notice period of 3 months. No refunds are given on installment payments. A late withdrawal fee will be issued if a family fails to notify the school within one month of withdrawing if you have previously stated that you are staying and have paid the deposit. The late withdrawal fee of 25%, in addition to the paid deposit, will be charged based upon the termly tuition fee.

Additional fees for non-obligatory trips such as The England trip, Downhill Ski trip, etc. apply.

Additional fees for purchases of items of school uniform apply.

Invoices for the fees are issued by the school's administration. If payment is not made by the stipulated day, an additional reminder fee of 300 SEK will be charged.

Failure to pay the fees will result in withdrawal of the child's place at the school.

The English Nursery Fees

For children aged 1-5, the Authorities regulate the fees if your child has a "personnummer" (Swedish Social Security number). Children enrolled at the Nursery pay according to a fee structure set by the Authorities. The Fee structure follows something called "maxtaxa". This is a variable monthly Fee set by the family's home council (kommun) and it's linked to the parents' joint income. In general, the maximum monthly fee is around 950-1100 SEK/month. The monthly fees apply for 12 months a year and no discount is given for days/weeks of absence.

As attending a nursery is not obligatory for these ages in Sweden the authorities will not subsidize children unless they have a valid "personnummer".

If your child does not have a "personnummer" the fee level paid by parents/guardians is much higher to compensate the loss of subsidies issued by the Authorities.

The period of notice for Nursery places are stipulated by the family's home council (kommun). During the period of notice the monthly fees must be paid to the Nursery regardless of whether or not the child still attends the Nursery. No discounts will be granted.

In general, invoices for the monthly fees are issued by the school's administration. However, some home councils (kommuner) choose to issue their own monthly fees. Please check with your home council (kommun) which system they use.

If payment is not made by the stipulated day, an additional reminder fee of 300 SEK apply. Two outstanding fees may lead to termination of the contract and your child's place is withdrawn.

TASC - The Tanto After School Club Fees

If you are offered a place at TASC the following fee structure apply. The Authorities regulate the fees if your child has a “personnummer” (Swedish Social Security number). Children enrolled at the TASC pay according to a fee structure set by the Authorities. The Fee structure follows something called “maxtaxa”. This is a variable monthly Fee set by the family’s home council (kommun) and it’s linked to the parents’ joint income. In general, the maximum monthly fee is around 950-1100 SEK/month.

As attending an after school club is not obligatory in Sweden the authorities will not subsidy children unless they have a valid “personnummer”.

If your child does not have a “personnummer” we regret to inform you that we cannot offer your child a place at TASC.

The period of notice for TASC places are stipulated by the family’s home council (kommun). During the period of notice the monthly fees must be paid to TASC regardless of whether or not the child still attends TASC. No discounts will be granted.
